Course Description

An exploration of some of the ways religious phenomena are studied. Attention is also given to the history of the academic study of religion.

Course Objectives

By the end of this course students will have:

- 1. Become familiar with leading scholars in, and influential approaches to, the study of religion;
- 2. Examined the development of the study of religion from the late 19th to early 21st centuries;
- 3. Evaluated critically the presuppositions of, and challenges to, the academic study of religion.

By the end of this course students will be able to:

- 1. Describe key differences in two or more approaches to the study of religion and their historical significance;
- 2. Develop appropriate questions for future research in religious studies;
- 3. Evaluate the scholarly debates in the past and present concerning the study of religion as an academic field.
